MEMBERSHIP AGREEMENT

This Membership Agreement (“**Agreement**”) is between Storytrails India Private Limited with its registered office at New no.34 old no.192, North Usman Road, Chennai, Tamil Nadu-600017 (hereinafter referred to as “**Company**” which expression shall unless repugnant to the context thereof mean and include its successors and assigns) of the One Part; and _____, Son/ daughter of _____, residing at _____ (herein referred to as “**Guardian**”) of the other part. The Company and the Guardian hereby agrees as follows:

1. The Guardian hereby agrees to enroll their child/ ward into the Trailblazers Club (“**Club**”) in accordance with the terms and conditions set out below.
2. The Company agrees to conduct trails and other activities (“**Activities**”) for the members of Club (“**Member**”).
3. By virtue of enrollment into the Club the Members shall be entitled to participate in the activities of the Club as announced by the Company from time to time.
4. The Company shall announce the fee applicable for each activity organized by it, and the Member shall be entitled to participate in these activities on payment of the specified fees. The Fee for enrollment is a non- refundable payment.
5. The Company shall be entitled to postpone or withhold the organization of the Activities at its discretion, and is also entitled to tailor any existing Activities as it deems fit.
6. Any change to the Activities shall be intimated to the Guardian.
7. The Company reserves the right to accept or reject any Member from the Club.
8. The Membership to the Club may be terminated at any point of time by the Guardian by informing the Company and following such instructions as may be delivered at the time of termination by the Company’s representatives.
9. The Guardian represents that he/ she has checked the suitability of the Activities for the Member. The Guardian acknowledges and agrees that there are risks of injury to person(s) and/or property that are associated with the Activities and that the Guardian voluntarily assumes such risks.
10. The Company shall use all reasonable efforts to procure the best services of all third party agents and carriers who are not in the direct employ of the Company.
11. Basic First aid shall be afforded to the Members during the course of the Activities.
12. The Guardian permits the Company to use photographs taken during the course of the Activities for publications on its web sites and/or in print advertising and for promotional literature.
13. This Agreement shall remain effective for a period of twenty four months from the date of registration. The membership to the Club shall be renewed thereafter by signing a fresh membership agreement.
14. The Company does not make any warranties or representations as to the accuracy, reliability or completeness of any information including historical or scientific facts provided during the course of the Activities. The Company shall not be liable for any loss, damage, liability or expense incurred or suffered which is claimed to have resulted from use of or reliance on such information, including without limitation, any fault, error, omission, interruption or delay with respect thereto.
15. The Company and/ or its representatives hereby assumes no liability in contract, tort or otherwise on account of loss of life, personal injuries or property damages to the Member arising out of any events, happenings or occurrence during the Activities except where such loss of life, personal injuries or property was caused by the fault or negligence of Company and/ or its representatives and except to the extent that such liability is imposed by law.

The services of carriers, hotels, camps and other third party suppliers engaged by the Company for the purposes of providing food, refreshments, lodging, transport and other facilities are independent contractors and are not agents, employees, or servants of, or joint ventures with the Company and the Company shall not be liable for any personal damage, loss of life or property or expenses incurred due to any act or omission on account of such third party suppliers.
